### Fineotex Chem - Board approves Bonus Issue

- Board has given authority to Compliance officer Mr. Abhay Vasant Nerurkar and Mr. Sanjay Surendra Tibrewala and Managing Director Mr. Surendra Deviprasad Tibrewala to make application to BSE for in-principle approval for Bonus Issue.
