14 lakh beneficiaries inoculated in India

Highest number of 1,84,699 vaccinations reported from Karnataka, Andhra Pradesh, Odisha and UP

6,241 sessions and 24,408 such sessions have been conducted across the country so far.

NEARLY 14 LAKH beneficiaries have been vaccinated against Covid-19 in the country, including 3,47,058 in the last 24 hours, the health ministry said on Saturday.

According to data released by the ministry, the highest number of 1,84,699 vaccinations in the country has been reported from Karnataka, followed by Andhra Pradesh (1,33,298), Odisha (1,30,007) and Uttar Pradesh (1,23,761).

As many as 1,10,031 beneficiaries were inoculated in Telangana, 74,960 in Maharashtra, 63,620 in Bihar, 62,142 in Haryana, 47,293 in Kerala and 38,278 in Madhya Pradesh, according to the data.

In a statement, the ministry said in the last 24 hours, 3,47,058 people were vaccinated in

As on January 23, 2021, till 8 am, nearly 14 lakh (13,90,592) beneficiaries have received the vaccination under the country-wide vaccination exercise," it said.

India's active Covid-19 caseload continued to manifest a downward movement and dropped to 1,85,662 on Saturday.

India's virus tally reaches 1,06,39,684

WITH 14,256 FRESH cases, India's Covid-19 tally climbed to 1,06,39,684 on Saturday, while 1,03,00,838 patients have recuperated so far, pushing the national recovery rate to 96.81%, according to the health ministry.

There are 1,85,662 active cases of the coronavirus infection in the country currently, which accounts for only 1.78% of the total caseload, according to data released by the ministry.

The Covid-19 caseload has mounted to 1,06,39,684 and the death toll due to the disease has climbed to 1,53,184, with the novel Coronavirus claiming 152 more lives in the country in a span of 24 hours, the data updated at 8 am showed. The case fatality rate stood at 1.44%.

According to the ICMR, a total of 19,09,85,119 samples have so far been tested for the viral disease in the country, including 8,37,095 on Friday. India's Covid-19 tally had crossed the 20-lakh mark on August 7 last year, the 30-lakh mark on August 23 and the 40-lakh mark on September 5. It went past 50 lakh on September 16 last year, 60 lakh on September 28, 70 lakh on October 11, 80 lakh on October 29, 90 lakh on November 20 and one crore on December 19.

The 152 Covid-19 fatalities reported in the last 24 hours include 50 from Maharashtra, 19 from Kerala, eight each from West Bengal, Uttar Pradesh and Tamil Nadu and seven each from Delhi and Chhattisgarh.

Covid-19 triggers antibodies from previous infections: Study

PEOPLE WITH COVID-19 may rely on antibodies created during infections from earlier coronaviruses to help fight the disease, says a new study that

may partially explain the difference in symptom severity between old and young patients.

"Our results suggest that the Covid-19 virus may awaken an antibody response that existed in humans prior to

our current pandemic, meaning that we might already have some degree of pre-existing immunity to this virus," said John Altin, a co-author of the study from the Translational Genomics Research Institute (TGen) in the US.

Thousands of Hong Kongers locked down to contain Covid-19

THOUSANDS OF HONG Kong residents were locked down on Saturday in an unprecedented move to contain a worsening outbreak in the city, authorities said.

Hong Kong has been grappling to contain a fresh wave of the Coronavirus since November. Over 4,300 cases have been recorded in the last two months, making up nearly 40% of the city's total. Coronavirus cases in Hong Kong's Yau Tsim Mong district, a working-class neighbourhood with old buildings and subdivided flats made up about half of the infections in the past week.

Sewage testing in the area picked up more concentrated traces of the Covid-19 virus, prompting concerns that poorly built plumbing systems and a lack of ventilation in subdivided units may present a possible path for the virus to spread.

Authorities said that an area comprising 16 buildings in Yau Tsim Mong will be locked down until all residents have undergone tests. Residents will not be allowed to leave their homes until they have received their test results

to prevent cross-infection. "Persons subject to compulsory testing are required to stay in their premises until all such persons identified in the area have undergone testing and the test results are mostly ascertained," the government said in a statement.

Hong Kong has previously avoided lockdowns in the city during the pandemic, with leader Carrie Lam stating in July last year that authorities will avoid taking such 'extreme measures' unless it had no other choice.

Chief minister Uddhav Thackeray and Deputy Chief Minister Ajit Pawar will inaugurate the jail tourism initiative at Yerawada Central Jail on the Republic Day, state Home Minister Anil Deshmukh said in a press conference. This is the first of its kind initiative in the country, he claimed.

"Jail tourism in the state will start from the Yerawada jail in the first phase. Students from schools, colleges and other people

"Under the British rule, several freedom fighters, including Mahatma Gandhi, Lokmanya Tilak, Motilal Nehru, Sardar Vallabhbhai Patel, Sarojini Naidu, Subhas Chandra Bose had been imprisoned in Yerawada jail and their memories have been preserved there," he said.

Deshmukh said that guides will be provided to the visitors and ticket prices will range from ₹5 to ₹50. "In view of the coronavirus pandemic, only 50 visitors will be allowed daily," he said.

The prisons in Thane, Nashik and Ratnagiri will also be part of the jail tourism initiative, the minister added.
